**PRODUCT DECLARATION & CERTIFICATION TO  
STATE OF CALIFORNIA PROPOSITION 65  
Updated Listing December 5, 2025**

This is to certify that the products manufactured by Monmouth Rubber & Plastics Corp., including Durafoam™ Closed Cell Rubber & Plastic Foam; Duraflex™ Solid Rubber & Plastic Sheet; and Bondaflex™ Recycled Rubber & Plastic materials, contain, in some instances, ingredients considered toxic under California Proposition 65 The Safe Drinking Water and Toxic Enforcement Act of 1986.

Some of the ingredients in Monmouth's products fall under the No Significant Risk Levels (NSRLs) for Carcinogens and the Maximum Allowable Dose Levels (MADLs) for Chemicals Causing Reproductive Toxicity.
